## The Community Initiatives Program – Mini-Grant Application

### PLEASE NOTE:

- \*If you are tax delinquent, you may still apply, however you must be up to date before receiving mini-grant funds.
- \*Loans up to \$5,000.00
- \*For exterior improvements only
- \*Contractor must use lead safe work practices
- \*For either owner-occupants (10% match) or investor-owners (100% match)
- \*You must attend a mandatory SUN informational session.

### INFORMATION FOR GOVERNMENT MONITORING PURPOSE
